Investment trusts are quoted companies listed on the London Stock Exchange. Their share price is determined by factors including demand, or lack of, which means that the shares may trade below (at a discount to) or above (at a premium to) the underlying net asset value.

A trust's net asset value (NAV) is calculated as available shareholders' funds divided by the number of shares in issue, with shareholders' funds taken to be the net value of all the company's assets after deducting liabilities. In line with current industry best practice NAVs are shown that take into account the 'fair value' of debt. This means NAVs are calculated after allowing for the valuation of debt at fair value or current market price, rather than at final repayment value. NAVs with debt at market value provide a more realistic impact of the cost of debt, and thus a more realistic discount.

Trust aim & characteristics

The Trust's objective is to increase its total return above the benchmark index of 50% FTSE All-Share and 50% FT/S&P World Index (ex UK sterling adjusted) over the long term, by investing in UK and international securities. The strategy of the Trust is designed to meet the requirements of those seeking a single investment in a diversified and professionally managed portfolio.

††The Trust also seeks to enhance returns for its shareholders through gearing, in the form of bank borrowings. Fund Managers' review

World equity markets continued to fall in March as deteriorating economic data from the US strongly suggested that the US was entering into a recession. The fall out from the credit crisis also continued to have a major effect on the markets, as the enforced sale of Bear Stearns to JP Morgan led to speculation on the liquidity of a number of other banks. Commodity prices remained at record levels through most of March as demand from the East and in particular China showed little sign of weakness. The portfolio performed in line with its benchmark in March, with the large overweight in Cobham and International Personal Finance the best performers; both companies announced results for 2007 that exceeded expectations. Veolia was the worst performing stock in the portfolio, as despite a profits increase, the growth profile of the company was seen as disappointing. Xstrata also disappointed after discussions with Brazilian miner Cia Vale de Rio about a potential £45bn takeover of Xstrata were terminated.




