Aim

The Trust's objective is to increase its total return above the benchmark index of 50% FTSE All-Share and 50% FTSE All-World Index (ex UK sterling adjusted) over the long term, by investing in UK and international securities. The strategy of the Trust is designed to meet the requirements of those seeking a single investment in a diversified and professionally managed portfolio.

Risks & Features

Investment trusts are quoted companies listed on the London Stock Exchange. Their share prices are determined by factors including the balance of supply and demand in the market, which means that the shares may trade below (at a discount to) or above (at a premium to) the underlying net asset value.

The Trust seeks to enhance returns for its shareholders through gearing, in the form of long-term, fixed rate debentures. Gearing can boost the Trust's returns when investments perform well, though losses can be magnified when investments lose value. History

The Trust was formed from the Brunner family's interest in the sale of Brunner, Mond & Co, the largest of the four companies which came to form ICI in 1926. The Trust has been managed by RCM (a subsidiary of Allianz Global Investors formerly Kleinwort Benson) since inception.

Fund Managers' Review

Global markets posted positive gains during February; economic data announced over the month continued to be mixed with US data considerably better than that of Europe. The US ISM manufacturing index reached 58.4, the highest level since August 2004 and US industrial production increased in January

by 0.9%, more than expected. In Europe Q4 GDP disappointed at 0.1% vs. 0.3% expected, ISM readings dropped and the prospect of a hung parliament in the UK led to a sharp fall in the value of the pound as investors speculated that the ability of the UK to reduce its debt would be affected. Sovereign risk in Greece and other peripheral EU countries also remained in the headlines, despite the EU endorsing Greek austerity measure to bring its budget under control. Not surprisingly, Europe lagged the performance of the rest of the world.

The Trust's NAV (+4.96%) slightly outperformed its benchmark (+4.8%) over the month. The best performers within the portfolio were consumer stocks with Compass and Estee Lauder performing well. Compass reported that sales declines had begun to slow in the three months to December and operating margin improved significantly. Estee Lauder, who are currently restructuring the business continued to perform strongly with strong second quarter results announced during the month.


